6. ACCIDENTAL RELEASE MEASURES

SMALL SPILLS

LARGE SPILLS

Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust. 7. HANDLING AND STORAGE
